- 1) If the value of work exceeds Rs 50,000/- then earnest money deposit will be @2% subject to the minimum of Rs 5000/- will be deposited in the form of DD in the favour of Addl. SE, P&M Div., PSTCL, Jagraon. Quotations without earnest money will not be accepted.
- 2) Tender will be opened at 11:30 Hrs on 24.01.24 and in case of holiday on that day, the quotation will be opened on the next working day.
- 3) The tender should be complete in all respects; incomplete tenders or telegraphic tenders are liable to be rejected.
- 4) GST should be indicated separately.
- 5) The rates should be firm F.O.R destination & filled by Firm as per Annexure-(A).
- 6) The rates should be valid for 120 days. If the firm fails to complete the work in stipulated period of Work order, the same is liable to be rejected and if accepted the firm will be liable to pay as penalty charges @ 0.5% of the cost of left over work per week for the delay or thereof subject to maximum of 10% of the cost of complete unit of pending work.
- 7) The payment will be made 100 % with 45 days through RTGS/NEFT after submission of Invoice/Bill once the work is completed.
- 8) Firm shall furnish copy of valid GSTIN and PAN. If all these documents are not provided along with quotation, the quotation will be cancelled.
