As per decision of Board of Directors of PSTCL taken in its 62nd Meeting held on 05.10.2020 at Mohali pursuing Agenda No.15/CE/HIS&D dated 24.06.2020 and Addendum thereof dated 05.08.2020, the Services of Engineers (Electrical) Regulations, 1965 is hereby amended to the extent as under:-

Feeder Cadre Post	Promotion Criteria
Regulation 10(1)(a) Non-Diploma Holder AAE	AAE having their record above average possessing minimum academic qualification of Matriculation or its equivalent and with not less than 12 years service as AAE and Technical Subordinate G-II, out of which a minimum service of 2 years shall be as AAE, will be promoted to the post of Assistant Engineer.
Regulation 10(1)(b) Degree/ AMIE/ Diploma Holder AAE	Junior Engineers holding 3 or 4 years Diploma in Electrical/Mechanical/ Electrical & Electronics Engineering or BE/B.Tech/B.Sc/AMIE Engg. in Electrical/ Electrical & Electronics Engg. or equivalent degree in respective discipline recognized by AICTE with Eight (8) years minimum service as AAE and Technical Subordinate G-II, out of which a minimum service of 2 years shall be as AAE, will be promoted to the posts of Assistant Engineer.
Regulation 10.7 AMIE/ Degree holder Technical Subordinates and Drawing Staff	Employees possessing AMIE/ Degree in Electrical/ Electronics and Communication/ Mechanical /Instrumentation Control/ Computer Science/ Electrical & Electronics Engg. or equivalent degree in respective discipline recognized by AICTE and who have completed three years service in that capacity i.e. three years service as AMIE/Degree holder JE/AAE.

Conditions in context to Regulation 10.7 above:-

1. Against Regulation 10.7 above, promotional case of Technical Subordinate G-II employee(s) shall be considered only after considering the promotional cases of all the working Technical Subordinate G-I employees.
2. All the promotions, against Regulation 10.7 above, shall be considered based on respective seniorities of Technical Subordinate G-II or G-I, as the case may be. There shall be no separate seniority of Technical Subordinate G-II or G-I under 14% quota. Separate seniority list of JE/Electricals already issued vide memo no. 12389/93 dated 07.08.2017 under 14% quota is quashed.

Further approval is also accorded as one-time measure to consider promotion cases of all the AAE/Electrical under Regulation 10.1(b) of the Services of Engineers (Electrical) Regulations, 1965 subject to condition of completing 7 years' service (both as JE and AAE), out of which minimum 1 year shall be as AAE/Electrical.
