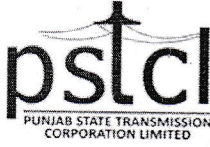

Punjab State Power Corporation Ltd. is pleased to approve payment of bonus for the year 2019-20 under Payment of Bonus Act, 1965 for PSPCL employees at the rate of 8.33% of the wages or salary earned by them during the year 2018-19. The bonus is admissible only to those employees of PSPCL whose salary or wages does not exceed Rs.21000/-PM. For calculation purpose where the salary or wage of an employee exceeds seven thousand, it shall be taken Rs.7000/- or the minimum wage notified for his category as per Labour Commissioner, Government of Punjab memo No.ST/27067 Dated 04.11.2019 (Table-1) whichever is higher.


Minimum wages during the year 2019-20 for scheduled employment under the Minimum Wages Act, 1948, were prescribed as per memo No. ST/27067 Dated 04.11.2019 issued by Labour Commissioner Punjab as under:

Category	Monthly Minimum Wages for 1.3.2019 to 31.08.2019 (Rs.)	Monthly Minimum Wages for 1.09.2019 to 28.02.2020 (Rs.)
Un-Skilled	8451.95	8776.83
Semi-Skilled	9231.95	9556.83
Skilled	10128.95	10453.83
Highly Skilled	11160.95	11485.83

Further, it is also decided that:-

- i) Keeping in view the terms of offer of appointment to newly appointed employees/officers that they are only entitled to fixed emoluments and no other allowance/increment/grade pay etc. (except TA) shall be admissible, bonus to such class of employees is not admissible.
- ii) Bonus is not admissible to retirees hired on contract as they are also drawing pension along-with fixed salary for contract period and sum of pension and contract salary always exceed the prescribed limit of wages under Payment of Bonus Act, 1965 of such retirees.
- iii) Field offices are advised to refer Government of Punjab, Department of Labour (Labour Branch) Notification dated. 15.11.2012 for determination of particular post/employee of un-skilled, semi-skilled, skilled or highly skilled category. Payment shall be made as per instructions issued by the office of Chief Financial Officer, PSPCL, Patiala.
- iv) The payment of Bonus shall be made with the salary of October-2020 before the occasion of Dewali.


