SCOPE OF WORK

- 1. The scope of work will broadly cover erection of 2 no. of ERS Tower, Including Excavation in normal soil including back filling etc, dismantlement and re-sagging of conductor 0.4 sq. inch. Zebra Double circuit including fixing of conductor accessories, dismantlement of ERS towersalong with accessories and supervision of all work for 220KV KHASSA-CIVILLINE/KHASSA-CHOGAWAN DC LINE on double ckt. Towers, passing NEAR KHURMANIA KHASSA DISTT AMRITSAR PUNJAB..
- 2. Bidder's scope shall include execution of complete dismantlement and erection work along with necessary spares and T&Ps, consumable and skilled/ unskilled manpower. It is advised to visit the site before submission of bid/ Tender.
- 3. The scope of work will also include such other related works although they may not be specifically mentioned above and all such incidental items not specified but reasonably implied and necessary for completion of the job as whole and as directed by the Engineer in charge. The scope of the work explained above is not a comprehensive list of items of work involved. The detailed scope of work may vary considerably depending on actual site requirements,
- 4. Transportation, Loading and de-loading of material till metaled road for the work shall be in PSTCL's scope, Transportation of material from that point of location of ERS tower through kachha path material is in the preview of contractor.
- 5. After the successful erection of the tower, dismantlement of ERS tower and the transportation of material from the location of ERS tower to metaled road through kachha path is in the preview of contractor.
- 6. ERS Tower material shall be handed over to the contractor on site by PSTCL and dismantled ERS tower material should be handed over to PSTCL. The contractor shall be fully responsible for safety and custody of the material till the successful completion of work.

- 3. If the quotations are not received in the office on time, then it will not be accepted.
- 4. The under signed can increase/ decrease the quantity of the work as per actual site requirements or cancel the quotations at any time without any notice.
- 5. No subletting of work shall be permitted at any stage.
- 6. Tender may be cancelled by the undersigned without assigning any reason.
- 8. Quoted rates shall include everything and nothing extra over & above the quoted rate shall be payable. GST (if applicable) shall be paid as per actual.
- 9. The quoted rates shall remain valid for 30 days from the date of the opening of bid.
- 10. Seventy percent (70%) of the bill price of the contract shall be paid within 15 days of submission of bill by the contractor to SR.XEN, P&M Division PSTCL civil line Amritsar. The payment shall paid by the officer after energization of Double circuit line on ERS tower certified by AEE/TL, PSTCL, sub division Verka. Balance Thirty Percent (30%) shall be paid within 15 days of dismantlement of ERS towers and handing over the material to PSTCL certified by AEE/TL PSTCL, sub division Verka.
- 11. Statutory taxes should be paid after allowing abetments/ discounts/ exemptions permissible under the relevant act so as to ensure that there is a least payment for PSTCL under the provision of law.
