- 1) General Terms & Conditions :-
- 1. The following documents are to be provided along with the tender/quotation:
 - a) Registration copy of the vehicle.
 - b) Route permit.
 - c) Receipt of Tax/MCV Tax certificate.
 - d) Copy of Insurance.
 - e) PAN card of Prop.
 - f) Copy of driving license.
- 2. The Work Order will be initially for a period of one year and the same will be extendable, on year to year basis, for further two years subject to the performance of the Vehicle/ Service Provider/ Market rates and the Life/Kms of the vehicle with the permission of competent authority.
- 3. The contractor is required to submit an Earnest Money Deposit (EMD) @2% of the tender value including GST subject to minimum Rs 5000 in the form of demand draft in favor of PSTCL Tender offers without EMD will not be accepted. The EMD will be adjusted against the 5% security & the same will be released as per PSTCL policy. Sealed tenders are invited in duplicate for LIMITED ENQUIRY NO 06/2023-24 due on 19.10.2023 FOR Outsourcing of one No. SCORPIO/XYLO /Mahendra Bolero /TUV 300 or Equivalent in price for the office of AddL.S.E. Sub Station PSTCL Nakodar.

The contractor will quote the rates as per Annexure 1 "Schedule of Prices" as under:

- a) Monthly Fixed Charges (Lump Sum) Including 1000km.
- b) Per Kilometer running charges after fixed Kms
- c) Outstation charges (per night halt after 22:00 hrs to 06.00 hrs).

(3) Terms and Conditions for Vehicles:

The contractor will depute one. SCORPIO/XYLO/Mahendra Bolero /TUV 300 or Equivalent in price for the office of AddL.S.E. sub Station PSTCL Nakodar for 1 year, vehicle should not more than 4 years old. The vehicle will be stationed at 400 KV. Sub Division PSTCL Nakodar.

- Only Commercial Vehicle with entry in Registration Certificate will be hired. No corporation employee or
 his family member /relative can participate in the tendering process .in case of any violation, the contract
 shall be cancelled and such employee shall be liable for disciplinary action.
- Vehicles should be available for use round the clock, for utilization at our offices in Punjab, Chandigarti, Delhi & Himachal Pradesh and also for deputing to the neighboring States of Haryana, Rajasthan and I&K.
- The necessary permit, in this regard, will be arranged by the Contractor. The toll Tax/Toll Barrier if applicable at any route will be paid by the PSTCL on production of actual receipts.
- 4. The vehicle should be insured comprehensively, including insurance for driver and passengers, during the period of engagement with PSTCL. Insurance premium shall be paid by the service provider. In case of any eventuality, lodging insurance claims with the insurance company shall be the responsibility of the service provider.
- 5. Road tax for the vehicle shall be paid regularly and kept updated by the service provider.
- Service Provider shall have valid pollution certificate for the vehicles and the same should be available with the driver to be produced on demand.
- The service Provider shall obtain the passing/ fitness certificate and update Registration of vehicle from the concerned authority at his own cost.
- Expenses towards fuel, Mobil oil, service charges and other repairs and maintenance of vehicles shall be borne by the Service Provider and the vehicles shall be always kept in good running condition. In case of breakdown of vehicle, alternate vehicle shall be made promptly available by the service provider.
- Cost of vehicle's registration, insurance, service/repair, road tax, salary//allowances of the driver or any
 other charges will be borne by the service provider. Only Fixed amount and variable charges for extra
 running kilometers, if any, will be paid by PSTCL.
- 10. Any Halt charges, penalty including challan, damages, court case, police case, etc. will be the sole responsibility of the service provider and PSTCL will not be party in such cases.

- 11. Vehicles shall possess an All India Permit. No liability for the Inter-State permit charges will be borne by PSTCL.
- 12. Toll Tax/Parking charges, etc. wherever paid, shall be reimbursed as per actual, subject to the production of its receipts.
- 13. Total liability including third party, if any, in case of the accident of the vehicle or due to any kind of act of omission shall be of the service provider. PSTCL, directly or indirectly, will not be responsible.
- 14. The service provider shall provide a reliable spare tyre, tools, spares and consumables, with every vehicle, in order to attend to minor repairs while travelling.
- 15. Service Provider will also ensure that the Drivers possess valid driver's license. Validity of Driver's license and fitness of driver should be ensured from time to time.
- 16. The driver shall be punctual and polite and shall not be under the influence of any intoxicating drink or drug. The service provider shall be responsible for the conduct of the driver. In case of any complaint regarding the conduct of the driver, he shall be replaced immediately.
- 17. In case any driver proceeds on leave or is not available on medical grounds or any other ground, alternate replacement shall be the responsibility of the service provider.
- 19. Maximum up to 4 days off in a month will be allowed including for service and upkeep of the vehicle, without any deduction of payment, provided the vehicle has been regularly in use prior to the service. This would be permitted on prior intimation to the concerned officer/office. Service shall be planned on Saturday/Sunday or public holidays. In case of non- availability of vehicle due to breakdown/ servicing on any working day, alternate vehicle shall be provided.
- 20. In case of non-deputing of vehicle on receipt of requisition from the requisitioning officer or delay in sending the vehicle, a penalty of Rs.1000/- per default shall be livable.
- 21. The contractor shall be liable to keep the vehicle in good condition at all times during the contract period. In case of breakdown, he shall provide another alternative vehicle of same type or equivalent, otherwise a penalty of Rs.1000/- per default shall be livable.
- 22. The kilometer run, from the point of departure of vehicle for maintenance/repairs, the time it run and rejoin the duties, shall not be considered for billing.
- 23. The vehicle shall report to the 400 Kv Sub-Division PSTCL Nakodar and shall move as per his instructions.
- 24. The vehicle shall be required at any hour of the day and the Contractor shall be liable to provide the same.
- 25. The vehicle shall be provided with step in tools, spares, spare tyre and consumables in order to attend minor repairs while traveling.
- 26. The seats shall be well cushioned and should have fine, neat and clean seat covers and vehicle shall also have rubber floor mats.
- 27. Log Book shall be provided by the PSTCL.

(4) Terms and Conditions for the Driver of the Vehicles:

- The contractor shall provide a driver along with the vehicle, who shall be properly dressed and well behaved, PSTCL reserve the right to direct the Contractor to replace the driver of the vehicle, if he is not well behaved. If Contractor is unable to provide another driver, the PSTCL has the right to terminate the contract awarded to the contractor. The salary and other expenses of the driver shall be borne by the Contractor.
- The Contractor shall also make available the Registration Certificate of the vehicle in his name with the driver of the vehicle along with all other relevant documents for insurance, Road Tax etc. necessary to keep the vehicle running on the road at all time during the contract period.
- The Driver shall maintain a Log-book & the log-book will be signed by the PSTCL's authorized official
 using the vehicle on the completion of the journey. However Log-book will be verified from time to time
 by the Addl. S.E. 400 Kv Nakodar or any officer of the Division.
- The Driver should have his own Mobile Phone with SIM of reputed company i.e. Vodafone, Airtel, and BSNL etc.
