

- 1 The vehicle is to be hired as per PSTCL Corporate transport policy (uploaded on PSTCL Website) and PSTCL Works Regulations 1997.
- 2 GST will be applicable as per Govt norms.
- 3 Conditional tenders will not be entertained.
- 4 The undersigned reserves the right to cancel/reject one or whole the quotations/Tender without assigning any reason.
- The tenderer is required to submit the necessary valid documents of vehicle like Taxi permit, Registration Certificate, Insurance of vehicle and license of driver and Pollution certificate and original bill/quotation etc.
- Only e-tendering mode will be acceptable. The e-tender should be submitted through online mode on the website (https://eproc.punjab.gov.in/nicgep/app)" or www.eproc.punjab.gov.in).
- 7 a.)Earnest Money:
 - The tenderers shall be required to submit 2% of tendered amount (Minimums ₹ 11,500/- for Earnest Money through online mode.
