Sub :- Purchase Order No.STP-2066/STQ-2045/TS-II dated 14.07.2020 placed on M/s Bajrang Wire Products (India) Pvt.Ltd., Jaipur for supply of 150MT of HTGSS Earth wire of size 7/3.15mm.

Dear Sir,

The subject cited P.O.No. STP-2066/STQ-2045/TS-II dt.14.07.2020 for supply of 150MT of HTGSS Earth wire of size 7/3.15mm was placed upon you. Your firm failed to complete the supplies against the above P.Os inspite of repeated reminders, 21 days notice was served upon your firm under "Negligence & Default" clause of purchase order vide this office Memo no.612 dt. 06.06.2022. But you have failed to complete the supplies as per respective provision of the above Purchase Order. For personal hearing, your firm was intimated many times (vide Memo no. 710 dated 05.07.2022 on 14.07.2022, Memo No. 750 dated 20.07.2022 on 29.07.2022, Memo No. 883 dt. 17.08.2022 on 30.08.2022, Memo no.898 dt. 30.08.2022 on 20.09.2022 and Memo no.984 dt. 22.09.2022 on 07.10.2022) and repeatedly schedule for personal hearing was extended due to non-responsive behaviour of your firm. At last your firm's authorized representative Mr. Lal Chand Kumawat visited in the office of CE/TS,PSTCL, Patiala on 07.10.2022 and replied that firm is unable to supply the material at the price of P.O. vide letter dated 10.10.2022.

The matter was put up to competent authorities of PSTCL and it has been decided as under:-

1. P.O. No. STP-2066/STQ-2045/TS-II dated 14.07.2020 placed on M/s Bajrang Wire Products (India) Pvt. Ltd., Jaipur for supply of 150MT of HTGSS Earth wire of size 7/3.15mm be and is hereby cancelled for balance supply i.e. 69.95MT HTGSS earth wire of size 7/3.15mm.
2. An amount of Rs. 2,33,420/- (Rs. Two Lac Thirty Three thousand Four hundred Twenty only) lying with AO/CPC as Security be forfeited alongwith the recoveries of any dues as per Clause 11 of the Schedule E of the Purchase Regulation, 2021.
3. The business dealings with the firm be suspended for a period of 3 years from the date of intimation letter to the firm regarding cancellation of Purchase Order as per Clause No. 13 "Blacklisting/Ineligibility of Firms of Purchase Regulation 2021".
