Terms & conditions

(I) General Conditions: -

- 1.0 The tender documents shall be issued only to those 1st class working building contractors who have enlisted with PSTCL, PSPCL, erstwhile PSEB, Pb PWD/B&R, MES, Railways & have satisfactorily executed similar work as specified in the DNIT.
- 1.1 The tenderer shall submit Rs.1000/- (Rs. One Thousand only) for tender in the shape of Bank draft or BA-16 in favour of Addl.SE./ C.W Divn., PSTCL, Jalandhar Payable at Jalandhar towards the cost of tender documents/ specification which is non-refundable.
- 1.2 Tender of such bidders who do not enclose the demand draft/B.A-16 of cost of tender document/ specifications shall not be opened.
- 1.3 All tenders must be accompanied by earnest money at the rates and in the form prescribed in the tender document except in the case of those tenderers who have specially exempted there under.
- 1.4 Conditional tenders will not be accepted. Tenderer will have to comply with all the rules and regulations under factory act, Industrial disputes act, E.P.F Act., Labour Laws and Bonus Act & Retrenchment compensation etc.
- 1.5 The tender shall be issued to those tenderers who have Vat No.& EPF No. Income Tax, Service Tax & Pan No.
- 1.6 Tender received telegraphically through telex or Fax/e-mail shall not be accepted.
- 1.7 The competent authority reserves the rights to reject any or all tenders without assigning any reasons.
- 1.8 In case the date of opening of tenders happens to be a holiday the tender will be received and opened on the next working day at the same time.
