Subject:- Selection for best managed Grid sub-station and transmission line Ref:- Dy C.E/Admn. Memo No- 924/29, Dated- 28-06-17 and Dy C.E/Admn. O/o No- 62, Dated- 28-06-17

It is an adopted practice of awarding best managed sub-stations and transmission lines in PSTCL by Worthy CMD during Republic day celebrations. To continue this tradition a new selection criteria for sub-stations and transmission lines has been prepared and enclosed herewith (A-1, A-2, A-3 & A-4). The previous selection criteria of selecting best managed sub-station and transmission line from all the 132 KV, 220 KV and 400 KV sub-stations and transmission lines under PSTCL doesn't give a fair opportunity to all the participants. In the previous guidelines issued for screening committee, few parameters were not applicable on 132 KV and 400 KV sub-stations. Since a new sub-stations always hold an advantage over the old sub-stations, so to establish a level playing field, it is proposed to select best managed sub-station and transmission line in each of the following categories-

- 1. 400 KV
- 2. 220 KV (upto 15 years old)
- 3. 220 KV (more than 15 years old)
- 4. 132 KV

Since no guidelines have been issued for selecting "Best Green Sub-station" as per Dy C.E/Admn. O/o No- 62, Dated- 28-06-17, so required guidelines have been proposed as per A-5.
