The Committee of Whole Time Directors of PSTCL in its 56th meeting held on 24.04.2015 at Mohali, considered CE/HPI Agenda No. 23/ Admn./PSTCL dated 17.04.2015 regarding the amendments in Rules and Regulations for various Departmental Accounts Examination (DAE) with regard to employees appointed by PSTCL and approved the following amendments:-

AMENDMENTS

- i) That Objective Type- MCQs method of assessment shall be adopted instead of the present conventional method for conducting Departmental Accounts Examination(DAE) of all the posts by PSTCL in the first session of 2015 onwards.
- ii) There will be 100 questions, each carrying one mark. Every question will be having four possible answers, one of these being the correct answer and other three options being incorrect. OMR checking method shall be adopted.
- iii) That **1** mark will be awarded for every correct answer and negative marking shall be **0.25** for every incorrect answer.
- iv) No books/copy of instructions or any other written/printed material shall be allowed in the examination for any category of post.
- v) Rest of the terms and conditions of DAE will remain the same.
