For the supply and installation of one or more of the following TIME MANAGEMENT & SECURITY SYSTEM at PSTCL Locations.

1. Bio-Metric Attendance Machine
2. CCTV surveillance system

I) Eligibility Criteria & Experience of Firms:

- i) The system integrator/ Suppliers should have experience (details of executed work orders to be enclosed) of successful completion(completion certificate to be enclosed)of similar work during last 7 years ending 31st March 2014 as follows:-
 - a) Three similar completed work each costing not less than Rs. 2.00 crores.
OR
 - b) Two similar completed work each costing not less than Rs. 3.00 crores.
OR
 - c) One similar completed work costing not less than Rs. 4.00 crores.

Similar Works shall refer to contracts in supply installation and commissioning of Time Management & Security System.

- ii) The system integrator should have completed atleast one work with a Government Organization/ PSU/Power Utility for which completion certificate must be enclosed.
- iii) One satisfactory performance certificate for atleast 2 years for the work executed during last 07 years, be also supplied.
- iv) The system Integrator should be an OEM for above mentioned equipment an authorized representative of the OEM for above mentioned equipments. The following documents must be supplied:-
 - a) Authorization certificates of OEMs to Quote for the EOI.
 - b) Brochure or Technical Data sheet or equivalent Document specifying the Technical specifications of the equipment.
 - c) Manufacturing experience giving details of manufacturing process and plant/machinery.
 - d) Authorized representative should have a back –end support agreement/arrangement for services with the OEMs (OEMs undertaking letter to be enclosed).

II) Financial Criteria:

The system integrator should have an average annual turnover of Rs.20.00 crores during last 3 financial years ending 31.03.2013. Audited balance sheets as documentary proof be enclosed. Firms shall also submit Solvency certificate from their bank.
