





3. The bidder shall submit to this office request for issue of tender specification along with experience details, copy of registration with PSTCL/PWD/ Irrigation /Public health /MS or any other public sector or Govt. undertaking, list of available T & P items, copy of

memorandum of incorporation of company and its registration with registrar of companies and income tax return filed with income tax department for last 3 assessments years.

4. The interested contractors / Firms must submit their request for issue of Tender Specifications by 14/02/2024 till 03.00 PM (cost of tender specification is Nil)
5. The tender specification shall be issued to eligible bidders by 14/02/2024 The detail of receipt & opening of tenders in this office are as given below:-

Opening of Tenders: 15/02/24 at 11:30 A.M.
Tender of the contractors who do not purchase the tender documents in advance shall not be received.
6. Requests for issue of tender documents received late due to any reason including postal delays or request not carrying information / documents asked vide Para 3 or request received through telex, fax, telegraphically shall be rejected. Conditional requests are also liable to be rejected.
7. Rates quoted in tender should be valid for 120 days.
8. Those bidders who are issued tender, specification are to submit their complete tender documents on or before the last date mentioned above along with fixed earnest money Rs (As per tender documents) . For more details on earnest money, tender documents may be referred.
9. Not with standing anything stated above, the competent authority reserved the right to assess the bidder's capabilities and capacity to execute the contract satisfactorily before deciding on issue of tender documents and even afterwards for deciding about awarding the work.

16. Security deposit 5% of the gross value of the work done will be deducted from the running bills as security deposit after adjusting the EMD. No interest shall be payable to contractor on the amount of security deposit.
17. Payment of the work done will be made by Sr Xen Civil maintenance P&M, Division, PSTCL, Patiala.

18. Bid Capacity:
The available Bid capacity at the expected of bidding (to be calculated on the basis of prescribed format vide Annexure 1&2) of the prospective applicant shall not be less than the estimated amount put to tender of intended job.

The bid capacity of the prospective bidders will be calculated as under:

$$\text{Assesses Available Bid Capacity} = (A * N * 2 - B)$$

Where

A= Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

B= Value of existing commitments and on-going works to be completed during the period of completion of the projects for which these bids are being invited.

N=The time period which varies from work to work, however most of works of WRD do fall in category N=0.5 (Value considered as per SBD for world bank projects)

The general formula is as detailed below:-

If, completion period < 6 months, N=0.5 Therefore,
Bid capacity = $A * 0.5 * 2 - B = A - B$

If, completion period < 12 months, N=1 Therefore,
Bid capacity = $A * 1 * 2 - B = A * 2 - B$

If, completion period < 18 months, N=1.5 Therefore,
Bid capacity = $A * 1.5 * 2 - B = A * 3 - B$

Bid capacity= $A \cdot 0.5 \cdot 2 - B = A - B$

If, completion period < 12 months, $N=1$ Therefore,
Bid capacity= $A \cdot 1 \cdot 2 - B = A - B$

If, completion period < 18 months, $N=1.5$ Therefore,
Bid capacity= $A \cdot 1.5 \cdot 2 - B = A - B$

If, completion period < 24 months, $N=2.0$ Therefore,
Bid capacity= $A \cdot 2 \cdot 2 - B = A - B$
