  - 1.1 The tenderers should enclose Rs.2000/- (Rs. Two Thousand only) in the shape of Bank draft in favour of Addl. S.E./ C.W Divn., PSTCL, Mohali Payable at Jalandhar towards the cost of tender documents/ specification which is non-refundable.
  - 1.2 Tender of such bidders who do not enclose the demand draft of cost of tender document/ specifications shall not be opened.
  - 1.3 All tenders must be accompanied by earnest money at the rates and in the form prescribed in the tender document except in the case of those tenderers who have specially exempted there under.
