## Subject: Payment of Remuneration to M/s B D Bansal & Co., Chartered Accountants and Statutory Auditors of PSTCL appointed by Comptroller & Auditor General of India for Financial Year 2020-21.

Pursuant to the decision taken by the Board of Directors of Punjab State Transmission Corporation Limited in its 64<sup>th</sup> Board meeting held on 18.01.2021, M/s B D Bansal & Co., Chartered Accountants, 7-GF, Sant Isher Singh Nagar Flats, Pakhowal Road, Ludhiana appointed by Comptroller & Auditor General of India as Statutory Auditors of the company for FY 2020-21 under Section 139 of the Companies Act, 2013, shall be entitled for remuneration of Rs. 3,50,000/- (Rs. M/s B D Bansal & Co., Statutory Auditors and its staff shall be entitled for reimbursement of TA/DA and hotel charges for performing journeys within Punjab and Chandigarh, where the auditors have no head office or branch office for conducting the Statutory Audit of the books of accounts of PSTCL, at the rates specified in TA regulations as amended from time to time as per entitlement of the officers/staff of the company along with hotel charges outside Punjab and Chandigarh. Reimbursement of the hotel charges shall be subject to non-availability of guest houses of PSPCL and PSTCL. For the purpose of TA/DA, Auditors and its staff shall be categorised as under:
