Amendment III

In Regulation 6 (i) sub regulation (a) dealing with Procurement through Open Tender, the amount be read as more than 5,00,000/- (each) instead of existing more than 2,50,000/- (each) for all individual items for inviting tenders through publicity.

Amendment IV

In Regulation 6 (iii) sub regulation (a) dealing with Procurement through Limited Tender, the amount be read as valuing upto Rs. 5,00,000/- (each) instead of existing upto Rs. 2,50,000/- (each) for individual item for inviting tenders from registered firms/contractors, through letters sent by registered post.
