Sub: Instructions regarding GST online software developed by the office of SE/IT PSTCL.

All DDOs are intimated that for compliance of GST, online software has been developed by the office of SE/IT PSTCL and is available at http://fmis.pstcl.org/gst/login.aspx . Login ID and Password has been sent to your official email ID. Keep in mind following points while entering the Vouchers on the above mentioned software:-

- 1. All types of invoices from 01-07-2017 should be entered in the software as per the fields provided in it.
- 2. No invoices prior to 01-07-2017 should be entered in the software.
- 3. Total tax liability as per GST returns sent by your office should tally with Account Heads 46.9 as per Account Circular No. 11/2017 dated 04-08-2017.
- DDOs should ensure that no information from sub offices remains left out. Wrong/nonsubmission of any information will be the responsibility of concerned DDO only.
- 5. All items of Sale/Purchase that are taxable, exempt under GST, Non GST items, covered under Reverse charge, Purchased from Person Registered under Composition scheme are to be uploaded/reported through the above software.
- 6. Due date for GST returns will be non-extendable under any circumstances.
- 7. The data for the month of 07/2017 must be entered and completed before 31-08-2017 positively. Late submission of data will not be entertained.
