The Punjab State Elacy Board is pleased to fix the rates of Counsel Fee payable to Board's Advocates for issuing Legal Notices on behalf of the Board:-

At present, norms of Counsel Fee payable to Board's Advocates are prescribed for conducting cases before the Distt. Courts and there is no provision for payment of separate fee where Legal Notice prior to institution of suit/ case is given on Board's behalf through Advocate.

Some offices oftenly seek clarification for payment of Counsel Fee reg. Legal Notices prepared and served on Board's behalf by the empanelled Advocates. In this regard, it is clarified that where after service of Legal Notice a suit is required to be filed, then no separate Counsel Fee over and above of the norms of suit fee shall be admissible. However, in such cases where Board gets the desired relief on service of Legal Notice and Civil Suit is not actually required to be filed then following fee shall be payable to the Board's Advocates:-

(b)	Junior Counsel	Rs. 125/-
