Subject: - Non Applicability of Section 206C of the Income Tax Act, 1961 i.e. Tax Collected at Source (TCS) on Purchase of Timber from Punjab State Forest Development Corporation Limited (PSFDC).

PSTCL is purchasing timber from Punjab State Forest Development Corporation Limited (PSFDC) for clearance of right of way for construction of new transmission lines on which TCS is being collected by PSFDC @2.5% as per section 206C of Income Tax Act, 1961 and the same amount is being claimed by the PSTCL in their income tax return.

This office has examined the matter & taken the expert opinion and concluded that Section 206C of the Income Tax Act, 1961 is not applicable on the PSTCL being a Govt. company and is not covered under the definition of buyer as per above said Section. Therefore TCS is not required to be paid on the purchase of Timber from Punjab State Forest Development Corporation Limited (PSFDC).

Therefore you are requested to take the matter with concerned authorities of Punjab State Forest Development Corporation Limited (PSFDC) for non-collection of TCS on sale of Timber by them to PSTCL.
