Subject: - Opening of New Account Codes for accounting of GST.

Government of India, Ministry of Finance, Department of Revenue, Central Board of Excise & Customs has notified to implement the Goods and Service Tax (GST) w.e.f. July, 2017.

To book the transactions arising due to introduction of GST, the following account codes are opened in the booklet "Chart of Accounts" (Commercial Accounting system Vol-I, Part-I):

46.990	SGST- Liability for Goods and Services Tax
46.991	CGST- Liability for Goods and Services Tax
46.992	IGST- Liability for Goods and Services Tax

Explanation: Amount of GST (SGST/CGST/IGST) collected by PSTCL on supply/sale of any type of Goods and/or Services by PSTCL to the third parties, will be credited to these account codes and while making the payment/depositing with GST authorities, the same shall be debited to these codes.

46.994 CGST- Liability for Goods and Services Tax under reverse charge mechanism

46.995 IGST- Liability for Goods and Services Tax under reverse charge mechanism

Explanation: The Liability of GST on account of receipt of Goods or Services from un-registered firms or on which reverse charge mechanism is otherwise applicable, will be credited to these account codes and while depositing with GST authorities, the same shall be debited to these account codes.

28.991 CGST- Goods and Services Tax paid for which Input Tax Credit is receivable

28.992 IGST- Goods and Services Tax paid for which Input Tax Credit is receivable

Explanation: These account codes will be debited for the value of GST paid to supplier of Goods and/or Services received for which Input Tax Credit is available. The same shall be adjustable against the liability for Goods and Services Tax after compliance of necessary provisions of the act.
