## Subject:- Transfer of unclaimed Security Deposit/EMD lying under GH 46.101 to revenue under Misc. Income GH 62.930.

Amount outstanding under GH 46.101 i.e. unclaimed Security Deposit/EMD of suppliers and contractors pending was discussed in the 45<sup>th</sup> meeting of Board of Directors held on 10.11.2017. It has been decided as under:

- 1. Unclaimed Security Deposit/EMD of suppliers and contractors pending for more than 5 years lying under GH 46.101 relating to closed POs/WOs be transferred to revenue under Misc. Income GH 62.930.
- 2. All concerned offices shall investigate the remaining amount outstanding for more than five years under GH 46.101 in respect of Security Deposit/EMD (excluding Permanent Earnest Money Deposit) relating to the firms which are/have not transacted with PSTCL since last five years or are/have not claimed the outstanding amount and will transfer the same to revenue as Misc. Income GH 62.930 with proper justification.
- 3. If any claim is made for refund of EMD/Deposit already transferred to income in future then the same shall only be refunded with the approval of Director/F&C after following the appropriate procedure.

All accounting units are instructed to incorporate the requisite JVs in Books of Accounts for implementing the above decision.
