Subject: -Transfer of material from one job to another job within same accounting

In partial modification of Accounts Circular No. 3/2016, the Note 2 appended below the Sr. No. 7 of ibid circular read with Accounts Circular No. 8/2016 is hereby substituted as under:

"Transfer of material from one job to another job outside the accounting unit or within the same accounting unit should be avoided as per instructions already contained in Chapter 23 of Material Accounting Manual. Only in case of emergency, it should be made with the approval of concerned Superintending Engineer and the same be routed through Stores. It should also be intimated to Chief Engineer/TS and CE/HR, SD & IT and SE/S&D (in-charge of store accounting unit) and respective accounting units along with the requisite documents with the value. In case of transfer of transformers by one P&M division to other or to other accounting unit the original cost and accumulated depreciation thereof (not on estimated value basis) shall also be accounted for in the respective accounting units. All other formalities like issues of SR, SRW and GRN etc. shall be completed with correct value for proper accounting thereof."
