Amendment in Accounts Circular No. 7/2017 & 9/2017 – instructions for **Subject:** accounting treatment of deposit/contribution works.

The instructions were issued for accounting treatment of transactions relating to deposit works and contribution works as per Chapter 7 of Capital Expenditure and Fixed Assets Manual (CEFA) vide Accounts Circular No. 7/2017 as amended vide Accounts Circular No. 9/2017.

As per the decision taken by BOD in its 51<sup>st</sup> meeting held on 26.11.2018, the note under Sr. no. 1 & 2 of above said circulars/instructions has now been substituted as under:

> "The unspent balance amount (i.e. excess got deposited on estimated basis after accounting for all the expenses relating to the work) of deposit/contribution works shall be refunded within a period of three months after completion of the works."
