30.04.2019.

In this regard as per the provisions of Section 7 of PSDT Act, 2018 read with rule 10 of PSDT Rules, 2018, "Every employer registered under the Act, shall furnish annual return in Form PSDT-6 for the financial year on or before the thirtieth day of April of the following financial year."

Further, as per Section 19(3) of the PSDT Act, 2018, where a registered employer or an enrolled person has without reasonable cause failed to file return under this Act within the requisite time, the designated officer may, after giving him a reasonable opportunity of being heard, impose upon him a penalty of rupees fifty only for each day of delay.

Therefore, it must be ensured that the annual return of PSDT for the FY 2018-19 shall be duly filed **on or before 30th April, 2019**. DDO shall be held personally responsible if any liability occurs on account of non-filing or delayed-filing of annual return under PSDT Act, 2018.
