Subject: Posting of Vouchers/Preparation of Accounts through New Online Accounting System/Software on real time basis w.e.f. 01.01.2021 onwards.

As you are aware that vide Accounts Circular No. 5/2020 the posting of Vouchers/Preparation of Accounts was made compulsory through New Online Accounting System/Software w.e.f. 01.04.2020. Preparation of Manual Cash Book as well as U-Cheque Cash Book was also dispensed with w.e.f. 01.04.2020.

Now, going one step further, it has been decided to prepare cash book in this New Online Accounting System/Software on real time basis. To achieve this it has been provided in Online Accounting System/Software that the cash vouchers of any particular day can be entered in the system only upto the end of next day i.e. 11:59 PM. For example cash vouchers of 01.01.2021 can be entered in the system only upto 11.59 PM of 02.01.2021 and not beyond that date. From 01.04.2021 the cash vouchers of a day can be entered in cash book upto 11:59 PM of the same day.

Therefore all the DDOs are requested to ensure the compliance of above instructions. This issues with the approval of competent authority.
