Charge Sheet No: 44 dated 18.11.2021 was issued against Sh. Jaswant Singh, JE, ID No: 601160 by the O/o Chief Engineer/ P\&M, PSTCL, Ludhiana; wherein the following charges were leveled:-

After considering the complete case of above cited charge-sheet, the following penalty was imposed upon Sh. Jaswant Singh vide Chief Engineer/ P\&M, PSTCL office order no: 195 dated 18.07.2022:-

> "Stoppage of one annual increment with cumulative effect."

Sh. Jaswant Singh preferred the appeal against the above mentioned penalty under the provisions of 'Punishment \& Appeals Regulations, 1971'. Accordingly, the copy of the said appeal was forwarded to the O/o Chief Engineer/ P\&M, PSTCL, Ludhiana for seeking their comments.

After the receipt of the requisite comments from O/o EIC/P\&M, PSTCL, the complete consolidated case pertaining to the said appeal was submitted before Director/ Admin, PSTCL for their kind consideration, being the Appellate authority.

Director/ Admin, PSTCL while considering the complete case decided to give the opportunity of personal hearing to Sh. Jaswant Singh on dated 19.04 .2023 before deciding the appeal.

Accordingly, Sh. Jaswant Singh appeared before Director/ Admin, PSTCL on dated 19.04.2023 and after hearing the official in person, Appellate authority has decided as under:-

[^0]After listening to the official's version and going through the record, it is decided to impose the penalty of 'Stoppage of one annual increment without cumulative effect' on Sh. Jaswant Singh instead of the previously imposed penalty of 'Stoppage of one annual increment with cumulative effect' vide Chief Engineer/ P\&M, PSTCL office order no: 195 dated 18.07.2022."

In view of the above, Punjab State Transmission Corporation Limited (PSTCL) hereby impose the penalty of 'Stoppage of one annual increment without cumulative effect' on Sh. Jaswant Singh w.r.t. Charge-Sheet no. 44 dated 18.11 .2021 instead of previously imposed penalty of 'Stoppage of one annual increment with cumulative effect' vide Chief Engineer/ P\&M, PSTCL office order no: 195 dated 18.07.2022
