	x) Erection of towers, tack welding of bolts and nuts including supply and application of zinc rich primer & two coats of enamel paint, tower earthing, fixing of insulator strings, stringing of conductors and earth wires along with all necessary line accessories;
	xi) Painting of towers & supply and erection of span markers, obstruction lights (wherever applicable) for aviation requirements (as required);
	xii) Testing and commissioning of the erected transmission lines and
	xiii) Dismantlement of towers alongwith conductor, hardware fittings & other line accessories.
