A. Earnest Money

All tenders must be accompanied by Earnest Money in shape of PSTCL cash receipt or pay order, demand draft in favour of PSTCL, Patiala in a separate envelope. Contractors who have already deposited Permanent Earnest Money (PEMD) with PSTCL are required to enclose copy of valid PEMD in separate envelop.

The tenders will be submitted in two parts i.e. Part-1 Containing Earnest Money & Part-2 containing Price Bid. Tenders without earnest money shall not be opened. Earnest Money shall be Rs. 27,000/-

Tenders shall be opened in the presence of the tenders or their authorized representatives who wish to be present.

- 1. A set of tender documents containing technical specifications general instructions, terms & conditions, and approved rates can be seen/obtained on any working day during working hours in the office of the Deputy Chief Engineer/TLSC Circle, PSTCL, Patiala.
- 2. The quoted rate should be valid for 120 days from the date of opening of tender.
- 3. All the T&P / machinery required to carry out the work is to be arranged by the Bidder.
- 4. Tenders for part work, Conditional tenders, shall not be accepted.
- 5. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time.
- 6. The competent authority reserves the right to increase/ decrease the scope of work or also reject any or all the tenders so received without assigning any reason whatsoever.
- 7. Bidders should note that, in case of award of contract they shall themselves be responsible for compliance of various provisions of EPF Act 1952 amended up to date as principal employer, work contract tax or any tax imposed by the State/Centre Govt from time to time. All obligations arising on this account shall be sole responsibility of the contractor. However Service tax and education cess thereon shall be paid extra as per actual paid by the bidder to the concerned department.
- 8. All terms and conditions of rate contracts & specifications of works (to which they relate) approved by the PSTCL shall remain unchanged in any circumstances if these are written incorrectly due to inadvertence at any stage.
- 9. Statuary taxes should be paid after allowing all abatements/discounts/ exemptions permissible under the relevant act, so as sto ensure that there is least payment for PSTCL under the provisions of law.
- 10. Guidelines issued by the PSTCL vide FR circular no. 1&2/2012 shall be applicable.
