1. 2. Earnest money shall be 2% of tender value with minimum of Rs.5000/- whichever is higher. Earnest money shall be nil for work order below Rs.50,000/- as per Works Regulations. The Earnest Money along with Documents should be kept in envelope duly sealed super-scribed "EARNEST MONEY" and Quotation should be kept in separate envelope duly sealed superscribed "QUOTATION".

3. Quotations not accompanying the EMD as per sr. no. 2 will not be entertained.

4. Tenders for part work, Conditional tenders, telegraphic tender through fax or tenders not on prescribed forms of tenders without earnest money in the required shape shall not be accepted.
