Providing Tractor/Tractors along with Diesel and operator at different sites coming under areas like Mohali, Rajpura, Patiala, Patran, Nabha, Lalru, Mandi Gobindgarh etc. for assistance during repair/breakdown/maintenance work of 400/220 KV EHV Transmission lines under O/o AEE/TL, Sub-Division-400 KV S/S, PSTCL Rajpura. The Tractor/ Tractors will be required for approx. 100 Hrs. of work (up to 31-03-2025). However the requirement of tractor and working hours may increase/decrease as per site conditions.

#### **Terms & Conditions:**

- a) Telephonic, e-mailed, Fax and conditional quotations will not be entertained.
- b) The firm should have registered GST Number.
- c) If the quotations are not received in this office on time, then it will not be accepted.
- d) Tenders are invited from registered firm/contractors which are registered with any of PSTCL/PSPCL/Power Grid organization/PWD, MES, Railways and other such Central/State Govt. Organizations.
- e) The Prices shall be of FOR destination at sites.
- f) The undersigned can increase/ decrease the quantity of work and no. of tractors as per site requirements or cancel the quotations at anytime.
- g) Payment will be made through NEFT by the O/o Addl. S.E./ 400 KV S/s, PSTCL, Rajpura through monthly billing on the basis of total hours of work done in a month after verification of bills by AEE/TL, S/D, 400KV S/s, Rajpura.
- h) The Tractor with Diesel and operator will be provided within one hour of telephonic intimation by AEE/TL, 400 kV S/s Rajpura or any representative of his office.
- i) The number of hours shall be counted after reaching the Tractor at site and up to completion of work as intimated by Engineer-Incharge.
- j) The firm/contractor may visit the O/o AEE/TL, 400 KV S/s, Rajpura on any working day/time before opening of tender for any clarification regarding work at different sites.
- k) The responsibility of any kind of damage/loss to the tractors or operator, if any, shall be of the contractors/firm only.
- I) The Tractors should be in working condition and operator should be skilled.
