

- 2. Work should be carried out as per specifications of PWD/PSTCL and as per PSEB Work Regulation 1997 amended from time to time.
- 3. No quotation will be received after prescribed date and time.
- 4. Any quotation with specified conditions by contractor will be automatically rejected.
- 5. The undersigned reserve the right to cancel the quotation without any cause.
- 6. The quoted rates should be including all taxes except GST, which will be paid extra as applicable. Any benefit to contractor due to implementation of GST will be passed on to PSTCL by contractor.
- 7. Quotation without earnest money will be considered cancelled.
- 8. 5% Security will be deducted from running bills.
- 9. Any rate above or below CSR should be in percentage form.
- 10. Overwriting and cutting in rates are not allowed.
- 11. DNIT will be issued upto 10.00 AM on 14/05/2025.
- 12. Quotation will be received upto 11.00 AM on 14/05/2025.
- 13. Quotation will be opened at 11:30 AM on 14/05/2025.
- 14. Corrigendum, if any, will not be intimated through Registered mail. As such, website www.pstcl.org may be visited regularly for updates.
- 15. Every tenderer shall produce a Bank solvency certificate from a scheduled bank, EPF code enlistment, GST No., PAN, Enlistment particulars, Work experience certificates etc., along with tender case.
- 16. In case the date of opening of tenders happens to be a holiday the tender will be received and opened on the next working day at the same time. Tender documents shall be issued to only those tenderers who prime facia meets aforesaid qualifying requirement. However, issue of tender documents shall not automatically construe qualification of the tenderer for the award of the work which shall again be determined during bid evaluation.

- 17. The tender documents shall be issued only to contractors who have enlisted with PSTCL, PSPCL, erstwhile PSEB, Pb PWD/B&R, MES and Railways. The tenderer should have satisfactorily executed similar work as mentioned below:-
- i) Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.
- ii) Experience of having successfully completed similar works during the last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: -
- a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost. or
- b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost. or
- c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- iii) Similar works means Construction of Switch House Building and Yard Foundations for structures of 66/132/220 KV Sub-Station or Construction of any other building work or bridge work or other works involving RCC Foundations, etc.
