Sub: Submission of Income Tax statement alongwith Form 12BB and documentary proofs of savings/deductions for finalization of Income Tax for FY 2019-20

To comply with the provisions of Income Tax Act regarding deduction of income tax from the salary, the income tax statements along with declaration in <u>Form 12 BB</u> (mandatory for claiming deduction/rebate) and documentary proof of saving/deductions admissible for the FY 2019-20 are required from all the officers working under your control, including your good self.

As such you are requested to ensure submission of income tax statements along with declaration in <u>Form 12 BB</u> and documentary proof of saving/deductions for the financial year <u>2019-20</u> to this office at the earliest <u>latest by 31-12-2019</u>. It is pertinent to mention that in case of payment of Interest/Principal on Housing Loan Advance, it is mandatory to submit the Permanent Account number (PAN) of the institution /Bank to whom Interest /Principal of Housing Loan is repaid.

In case of non-submission or late submission of above stated documents, TDS on salary will be finalized on the basis of record available in this office & tax will be deducted from the salary accordingly.
