Order

In compliance of the guidelines issued vide letter no. 7/56/2020/2H4/481-482 dated 25.01.2022 by Government of Punjab, Department of Home Affairs, I, Sandeep Hans, IAS, District Magistrate Patiala, in exercise of powers conferred under Section 144 of CrPC and Section 30 to 34 of the Disaster Management Act, 2005 hereby order the following restrictions in the <u>entire District from</u> 26.01.2022 to 01.02.2022:-

- 1. Social distancing and wearing of masks
 - a) Wearing of masks by all persons in public places, including workplaces etc.
 will be mandatory and must be strictly observed and enforced.
 - b) Social distancing i.e. minimum 6 feet distance (do gaz ki duri) for all the activities shall always be maintained.
- 2. Nigh. Currew from 10:00 pm to 05:00 am in all cities and towns:

Morement of people for all the non-essential activities shall remain prohibited untween 10:00 pm to 5:00 am within municipal limits of cities and towns (Patiala, Nabha, Rajpura, Samana, Patran, Dudhansadha, Bhadson, Sanour and Ghanour) of District Patiala.

However, essential activities including operation of multiple shifts in industry, offices etc. (both Government and private), movement of people and goods on National and State Highways and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains, and aeroplanes will be permitted. Newspaper hawkers and Milkmen are also exempted for their arrangements and services of home delivery. There shall be no restriction on movement of raw materials, finished goods, personnel etc related to manufacturing of pharmaceutical drugs, including vaccines and medical devices, diagnostic testing kits etc.

 Gatherings in marriage palaces/ resorts shall be restricted to not more than 300 persons (Indoors as well as Outdoors) subject to an upper limit of 50% of the capacity. These gatherings shall be subject to compliance of COVID appropriate behavior.

4. Online teaching/distance learning to be encouraged

All schools, colleges, universities, coaching institutions etc shall remain closed. However, these institutions are expected to maintain the academic schedule through online teaching. However, medical and nursing colleges may continue to function normally.

5. Prohibited/ Restricted activities

a) All bars, Cinema Halls, Multiplexes, Malls, restaurants, spas, gyms, sports complexes, museums, zoos etc. shall be allowed to operate at 50% of their capacity subject to all staff present being fully vaccinated.

CORO Patista

b) AC buses will run at 50% of capacity.

6. Principle of No Mask - No Service

No Service shall be provided in Government or private offices to the persons not wearing proper mask.

- Only passengers who are fully vaccinated, or Covid recovered, or with negative RTPCR report of last 72 hrs shall be allowed entry in the district from outside Punjab. In case a passenger doesn't have either of these, RAT testing shall be mandatory. Passengers travelling by flights shall be mandatorily required to be fully vaccinated, or Covid recovered, or with negative RTPCR report of last 72 hrs.
 Persons with disabilities and pregnant women employees shall be exempted from
- Persons with disabilities and pregnant worker on personal attending office but are required to work from home.
- Adequate publicity of all above restrictions to be done by District Public Relation
 Officer, Patiala to ensure awareness among the general public.
- All the directives of MHA/State Government including keeping social distance of minimum. 6 feet distance (do gaj ki doori), regulating crowds in markets and public transport and wearing of face masks in public places/ workplaces and during mansport and prohibition of spitting in public are to be strictly observed.

Any violation of these guidelines shall be punishable under sections 51 to 60 of the Disaster Management Act, 2005 and provisions of the Epidemic Diseases (Amendment) Act, 2020 besides legal action under section 188 of Indian Penal Code (IPC), 1860.
