A) Entitlements:

*Note:- The new internet connection shall be allowed to AE/AEE/AO or equivalent who are having an independent office on the basis of requirement of office with the recommendation of respective HOD.

As per the above, the officers are allowed to hire the telephone/internet services of any service provider with any technology (e.g Copper, Fibre or Wireless), where monthly rent is equivalent or less than the above entitled monthly limit.

- B) Approving/Sanctioning Powers delegated:
 - i) CE/HIS&D is authorized to sanction for replacement/change of existing telephone lines/Internet connection for the offices of CMD, Directors, Company Secretary & Office of CE/HIS&D and offices subordinate to them within the entitled limit.
 - For other offices: Concerned HOD has full powers to sanction for replacement/change of existing telephone lines/Internet connection for their own offices and offices subordinate to them within the entitled limit.
 - iii) For installation of new telephone lines/Internet connection, power will remains with the committee comprising of Director/F&C and Director/Admin. Dy. Secy/General shall be the convenor of the committee. The case be put upto the committee with the recommendation of concerned HOD.
 - iv) All the existing norms/Circulars/ office orders of PSTCL/erstwhile PSEB related to the telecom policy will be superseded with implementation of this new telecom policy.
- C) No separate telephone connection shall be allowed for fax machines except the office of CMD.
- D) The telecom policy of PSTCL will be reviewed after a period of one year along with the policy of PSPCL and Punjab Government.
