Subject: Regarding marking of cases, accepting of Notices from Punjab & Haryana High Court and payment of fee to Advocates.

Please refer to this office memo No 21908/21992/LB-2(51475)03 dated 8-10-03 and AG, Pb D.O. No. 3444-45 dated 28-11-2003 on the subject cited above.

It was requested that whenever Advocates on the approved panel of PSEB accept Notices of the cases from the Hon'ble High Court, the matter should be brought to the notice of A.G. or Legal Advisor/Secretary of the Board. The case may not be handled by them without proper assignment as it creates complications for making payments to the Advocates. No fee will be payable in the case in which Hon'ble High Court passes orders without filing of written statement & arguments by PSEB. No Advocate is expected to raise any fee bill in such cases. However, we have been receiving bills from Advocates for full fee even in such cases, which have been viewed seriously.

You are, therefore, advised to get such cases assigned from PSEB and not to approach A.G. office directly for assignment. In case Hon'ble High Court passes orders without filing of written statement by PSEB and/or argument on the case, no fee bill be raised by any Advocate in future.
